
Part 1.2: Landscape Paragraph

Beacon College Prep is entering its first year of operation. Although this is not the circumstances in which we thought to be opening, our resolve and dedication to opening a school built upon academic rigor, purposeful structure, and joy remain as strong as ever.

Our school was built to support the anticipated learning gaps seen in elementary schools across our community. Although our academic plans have changed, we believe our academic models will allow us to effectively remediate first-grade scholars who missed learning time last year, as well as our new kindergarten scholars. Our team has conducted parent surveys in recent months to ensure families and key stakeholders had a voice in creating our plan as well as assessing family needs in technology, childcare, and other resources. The Beacon College Prep CLP includes information about our plans to offer virtual schooling and associate policies, professional development for staff, school operations, instructional and technology plans, among other things.

Beacon College Prep's CLP relies on quality virtual instruction to effectively teach and remediate our scholars. We plan to begin our year with 100% remote learning for 100% of our scholars. 3.1: Explanation of Approach

Beacon College Prep has prepared to begin the school year with a fully virtual model. In this fully virtual model, Kindergarten scholars will receive 5 hours of instruction daily. First Grade scholars will receive 6.5 hours of instruction daily. Each day scholars will receive instruction in Literacy, Mathematics, Science/Social Studies, RTI, Character Development/Social Emotional Learning, and Physical Education. Scholars will be expected to attend virtual sessions according to their schedule every day. However, families that are unable to provide their scholar support needed throughout the day will have access to recorded mini-lessons from the day, so that work can be completed asynchronously.

Although these curricular materials were planned to be implemented in a full class setting, we strongly believe that live teaching from a teacher will still prove these materials effective.

Our mini-lessons are followed by check-in and support time to individual scholars where teachers are able to provide feedback and assistance to scholars as needed. Additionally, our afternoon maximizes teacher time by scheduling phone calls with families as needed.

Beacon College Prep students participating in virtual learning students will be accounted for via Google Meets, during virtual arrival from 7:45 am - 8 am. Teachers are required to record attendance within the Shelby County Schools district provided PowerSchool. Any student arriving at school after 8:00 am will be marked as tardy by the Operations Assistant. The Operations Assistant will also pull participant reports in Google Meets frequently after 8 am to account for all virtual learning tardy students.

SECTION 5: INSTRUCTIONAL TECHNOLOGY

Part 5.1: Explanation of Approach

Beacon College Prep will have a 1:1 ratio of technology to all staff and scholars. Each scholar will receive a Chromebook for use at home during virtual learning, which will also be used in classrooms during an eventual return. All teachers have been provided with a 13" Macbook Air. In classrooms teachers also have access to mounted projectors, Elmo document cameras, and high-speed internet. GoGuardian allows Beacon College Prep's IT service provider (Technology Lab) to monitor, track, and troubleshoot technology issues remotely for both scholars and staff.

Technology will be distributed to staff members during Professional Development and onboarding, followed by professional development sessions related to virtual instruction. Scholar computers will be distributed during the second week of August. Families will be trained in supporting virtual learning from home, be familiarized with our learning tools, and know who to reach out to with any needs. Scholars will also be familiarized with technology during these sessions and throughout the early part of the school year.

SECTION 6: PROFESSIONAL DEVELOPMENT

Part 6.1: Explanation of Approach

Meaningful professional development not only leads to better results in the classroom but also helps to retain high performing teachers. We plan to utilize (1) 17 days of summer professional development, (2) 2.5 hours of PD weekly, (3) 10 full-day professional development including 4 data days, (4) weekly collaborative planning, and (5) target coaching and feedback cycles. Professional development will consist of building teacher capacity in school culture, curricular choices and delivery, school systems, and family relationships, among other topics. Increased attention in Summer PD will be given to developing virtual teaching capacity and routine building. Our artifacts show a focus on preparing our teachers to meet the unique needs of all Beacon scholars including English language learners, and scholars with disabilities, in both the virtual or in-person setting.

The Head of School will continuously monitor local COVID-19 data and adjust decisions accordingly. In addition to monitoring outbreak data, the Board of Directors will govern towards meeting the needs of our community while ensuring compliance in regards to school operations, finance, academic progress, and school safety.

Beacon College Prep has been working hard to be proactive and vigilant pertaining to coronavirus (COVID-19) since the virus arrived in the U.S. at the end of February. Our goal is to keep Beacon's community informed, maintain transparency, and keep all channels of communication open. Connecting in both English and Spanish, Beacon updates families and stakeholders weekly, using one or more of the following tools: email, phone, social media, school website, and USPS mailers. To date, we have hosted four virtual information sessions via Facebook providing information to families about Beacon College Prep and our plans for the 2020/2021 school year - sent over 50 emails updating families on how to stay engaged and resources within the city to assist with their needs during the pandemic - and hosted weekly social distanced enforced office hours. Our goal is to be a source of support for our community and offer valuable reassurance during this difficult time.
