Types of Detention Facilities in Tennessee


- Juvenile Detention Centers (JDCs)
- Youth Development Centers (YDCs)
- Community Placements
- County/City Jails
- Correctional Complexes





Number of Facilities by Type

- 17 JDCs
- One YDC
- Two Prisons





Juvenile Detention Facilities (Short-Term Placement)

- There are 17 JDCs licensed by DCS.
- The local education agency (LEA) is the county in which the facility is located.
- School days vary by facility.
- Most JDCs have certified special education and general education teachers; however, all **should**.
- Average length of stay is three days but can be up to 1+ years.



Youth Development Centers (Long-Term Placement)

- Wilder Youth Development Center
 - Youth are placed in a YDC for the following:
 - Conviction for three or more felonies and/or
 - Conviction of any sexual offense.
- LEA: Department of Children's Services
- Traditional school schedule of five days a week
- Certified special education and general education teachers
- Credit-bearing classes
- Diploma and High School Equivalency Test (HiSET) options available



Correctional Complexes (Long-Term Placement)

- Northwest TN Correctional Complex and Debra K Johnson Rehabilitation Center for Women
 - Youth are placed in "prison" when they are charged as an adult and found guilty of at least one aggravated felony offense.
- LEA: Department of Corrections
- Traditional school schedule of five days a week
- Certified special education and general education teachers
- HiSET option <u>only</u>
- Access to TCAT and other post-secondary opportunities once the student is 18 years old

Laws Applicable to Juvenile Justice Education





Every Student Succeeds Act (ESSA)

- Provisions in ESSA help support and improve access to educational services in correctional facilities.
- ESSA places increased emphasis on smooth transitions from school systems to juvenile justice placements and back.
- It requires state agencies to establish procedures for assessment of youth when entering a juvenile justice facility.



Individuals with Disabilities Education Act (IDEA)

- Federal law addresses the provision of services to students with disabilities who are incarcerated.
- Unless specified, all requirements apply to state and local juvenile and adult correctional facilities (34 C.F.R. § 300.2).





IDEA: Child Find Requirements

- State and local agencies are required to establish procedures to identify, locate, and evaluate students in correctional facilities who have or are suspected to have a disability (34 C.F.R. § 300.111).
- The timeline for conducting initial evaluations (60 calendar days) applies, and the agencies must coordinate to ensure that the evaluation is completed (34 C.F.R. § 300.301).



IDEA: FAPE Requirements

- A free appropriate public education (FAPE) must be made available to children with disabilities ages 3 through 21 (34 C.F.R. § 300.101).
- FAPE must be provided through the provision of comparable services when a student transfers to a correctional facility (34 C.F.R. § 300.323 (e)).
- Records must be transferred as expeditiously as possible and "reasonable steps" must be taken to transfer records to and from correctional facilities (34 C.F.R. § 300.323 (g)).



IDEA: FAPE Requirements

- Least restrictive environment (LRE) requirement applies, and correctional facilities may not routinely place all students with disabilities in classes that include only students with disabilities (34 C.F.R. § 300.114).
- Transition services must be provided unless the student has been convicted as an adult and IDEA eligibility will end prior to being released (34 C.F.R. § 300.320, 34 C.F.R. § 300.324 (d) (ii), Tennessee Special Education Laws Chapter 0520-01-09-.05).



IDEA: FAPE Requirements

- Students in *juvenile* correctional facilities must participate in state and district assessments with appropriate accommodations (34 C.F.R. § 300.114 (a) (6)).
- The discipline protections apply, and a manifestation determination review is required if the student is removed from the educational placement for more than 10 days (34 C.F.R. § 300.530).
- Personnel providing special education and related services in the correctional facility must be appropriately licensed to provide the services (34 C.F.R. § 300.156).



T.C.A. § 49-6-3023

 Under state law, as of 2018-19, districts must provide educational services to students incarcerated in juvenile detention centers (JDCs) licensed by DCS.



Coding Refresher for JDC Placements



The Purpose of Proper Coding

- Establishes streamlined accountability
- Determines funding implications
- Promotes stability for students





Coding Refresher

• When a JDC notifies an LEA that a general education student has been detained:

The student remains enrolled in the LEA regardless of the location of the JDC.

The LEA enters the juvenile detention center student classification for the facility (see the JDC student classifications slide) in SIS and uploads to EIS.

The juvenile justice (JJ) point of contact (POC) plans for the student's educational services with the JDC and the other LEA if the JDC is in another district.

If the student is placed in a JDC in another district, the juvenile justice POC works with the receiving LEA to ensure that all educational records are received in a timely manner and that the student is coded properly in the student information system.



Coding Refresher

• When a JDC notifies an LEA that a special education student has been detained:

The student remains enrolled in the LEA <u>only if</u> the JDC is located within the LEA.

The student is withdrawn from the home LEA and enrolled in the receiving LEA if the JDC is in another LEA.

This process ensures that the receiving district, which is responsible for compliance with IDEA, has access to the IEP in EdPlan (EasyIEP).

The LEA that enrolls the student during the incarceration enters the juvenile detention center student classification for the facility in SIS and uploads it to EIS.

Service Timeline for JDCs



Educational Services Timeline: The First Month

Annually

Each district has a JJ point of contact & must submit a request to TDOE if he/she is not the attendance coordinator.

Within five instructional days

The receiving LEA must request transcripts & educational records from the sending LEA. The student must take an academic pre-test.

Within ten instructional days

The sending LEA must send the student's records to the requesting LEA (JJ POC). Special Education services <u>must</u> begin.

Within 15 instructional days

An Educational Service Plan (ESP) must be developed for each youth. The receiving and sending LEAs must work together to create each ESP.

Within 20 instructional days

The LEA where the JDC is located must begin providing general education services and instruction. This can be done by certified teachers, accredited on-line platforms or a hybrid.

Educational Service Plan (ESP)

• ESPs are designed to ensure collaboration between the sending and receiving school districts to ensure students remain on track in their coursework.

Key Points

- ESPs must be developed by the student's 15th instructional day.
- Members from both the sending school district and the receiving school district must be involved.
- JJ POCs are responsible for facilitating ESP meetings.






Steps to Examine Data—Internally

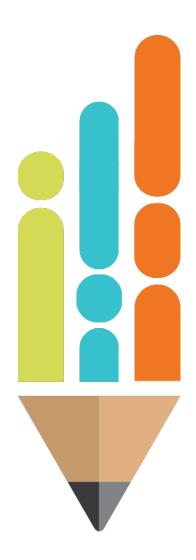
 Run a query in your student information system (SIS) for all JDC 01-17 codes.

 Compare the numbers from this report to the FPO JDC Data email from <u>Trish.Kelly@tn.gov</u>.



Steps to Examine Data—Externally

- Compare the numbers from your tracking document to the FPO JDC Data email from <u>Trish.Kelly@tn.gov</u> (sent quarterly).
- Reach out to the other LEAs to discuss any coding discrepancies.
- Make an appointment with Erin and Trish to review your data and revise your procedures if needed.








Step-by-Step Instructions for JDC Coding
