





Goals should always be aligned to a prioritized need.

How can funds supports the prioritized needs to place the district on a trajectory toward goal attainment?

- Consolidated Funding Application
- School Improvement Grants
- CTE Perkins
- ESSER
- Federal/State Funding

What is a strategy

A strategy is a path you choose to address the prioritized needs to achieve your goals.

- A good strategy articulates a clear roadmap for how you will make a change or improvement.
- Strategies define the things the people in the organization should prioritize (and not prioritize) to achieve desired goals.
- Strategy descriptions should clearly articulate how the strategy will move toward the overall goals.



Frequently Asked Questions

- What is allowable to fund?
- What does reasonable and necessary mean?
- Can I use the funds to purchase incentives?
- Can I use the funds to pay bonuses? Stipends? Travel?
- Can I use the funds to pay a higher salary than what my district pays?
- Can I use the funds to purchase food? Furniture?
- Can I use the funds for a multi-year contract? Or multi-year salaries?
- How do I know the funds are obligated?
- When can I spend the funds?
- How can I spend unused funds in a particular line item?

Why Monitor?

"Three general steps shape the design and implementation of effective systems.

- 1. First, leaders identify a set of starting leading indicators based on known success factors.
- 2. Second, they zealously monitor these indicators for signs of impending success or failure.
- 3. Finally, they act on what the indicators reveal, using data to target assistance, modify investments, or redirect focus."

Benchmark indicators are the leading indicators that gauge the strength of implementation and effectiveness of a particular strategy

Inputs:

measure how/if the strategy is being implemented

Outputs:

measure changes to student and/or adult behavior

Outcomes:

measure actual improvements (usually in student learning, behavior, and/or mindset)



Implementation, Effectiveness and Return on Investment

Implementation	Effectiveness	Return on Investment
Implementation is the carrying out of planned, intentional activities.	Effectiveness means the degree to which something is successful in producing a desired result; success.	Compares how much you paid for an investment to how much you earned to evaluate its efficiency.
Are we doing what we said we were going to do?	Is it working?	Did we benefit?
