

TCA Code §49-3-316 requires all final expenditure reports (FERs) be submitted to the TN Department of Education on or before October 1. The department strongly suggests completing all FERs as soon as possible after July 1. Grant managers may request FERs be completed prior to the October 1 deadline.
