General Sessions

An Introduction to EDGAR

Does your 5th Edition of the *Administrator's Handbook on EDGAR* have a layer of dust on it? Has it been a minute since you reviewed the U.S. Department of Education's General Administrative Regulations? Whether it is day 1 in your role as a program coordinator or year 31 as a federal programs director, participants will find this review on the basics of EDGAR beneficial. This general session will:

- identify key definitions to better understand future EDGAR-related general sessions.

Over the past two days, participants learned what policies, procedures, and practices must be implemented for the current school year to be compliant with EDGAR. Prior to this session, participants may feel like there is a "mountain" of changes, but this session will help attendees be on the "lookout" for the changes ahead given that an updated version of EDGAR has been published online. While we await a 6th Ed. of the *Administrator's Handbook on EDGAR*, attendees will receive an in-depth look at the adjustments required and additional flexibilities allowed in this recently adopted version of general administrative regulations.
