Join us for General Sessions such as **Current Trends & Litigation** by Julia Martin, Esq. of The Bruman Group, PLLC to learn about the current happenings in Washington, D.C., and their impact on Federal Programs, your GPS update for navigating the twists and turns of federal education policy.

Then, we'll take a comprehensive trip through the current landscape of federal education funding to better understand the smooth routes and the potential detours that come with managing Federal Programs. We'll begin by reviewing the current landscape LEAs (and SEAs) must navigate that allow for efficient and strategic use of funds under ESSA, IDEA, and Perkins V.
